The court held an unrecorded telephone conference in this matter on July 2, 2018. Participating in the conference call were the following: Melissa Hewey, Esq., David Kallin, Esq., and John Brautigam, Esq. for the Plaintiffs; Patrick Strawbridge, Esq., for the Defendants, and; Assistant Attorney General Thomas Knowlton, Esq., for the Commission on Governmental Ethics and Election Practices. Based upon the discussion during the conference call, and with the agreement of all participants, the court established the following schedule in this matter:

On July 2 or 3, 2018 the Plaintiffs shall file their Amended Complaint.

On July 6, 2018, the Plaintiffs shall file their main combined brief on the Motion for Preliminary Injunction and the merits of the action.


On July 13, 2018, the Defendants shall file their brief in response, and the Commission may file a response as well.

Oral Argument on the Motion for Preliminary Injunction and the merits shall be held on July 24, 2018 at 1:00 p.m. at the Androscoggin County Superior Court in Auburn.

The participants may file any objection to this Procedural Order on or before July 6, 2018.
